



Medical certificate template: Participation in teaching by people at particularly high risk in the fall semester 2020

According to the University of Basel’s study regulations, students who are unable to attend classes or examinations must provide a medical certificate. In addition to the measures defined in the university’s **COVID-19 safety concept**, students must submit an **application** and a **valid medical certificate** to the **Office of the Dean of Studies** in advance. This will ensure the best possible protection for people who are at particularly high risk.

Requirements and deadlines: Participation in teaching by people at particularly high risk in the fall semester 2020

- The **Dean's Offices** are the first point of contact for students who are at particularly high risk of COVID-19.
 - **Applications** for changes to **classes** and **examinations** must be submitted in writing to the relevant Dean's Office by the **end of the registration period** (fall semester 20: 12 October 2020).
 - The application must be accompanied by a valid **medical certificate** (based on the template).
 - The university endeavors to enable those concerned to participate in teaching within the scope of the existing possibilities and in accordance with the principle of equal opportunities. Participation in a specific class cannot be guaranteed in every case.

- Extract from the **COVID-19 safety concept** for in-person teaching in the fall semester 20/21:
 - 3. *General conduct*
 - ...
 - Compulsory face masks*
In the university library and university buildings in which classes are held, masks must be worn in foyers, corridors, lifts, stairs and study rooms, effective from 14 September 2020. Notices to this effect will be displayed at building entrances. Special provisions apply to lecture halls and seminar and practice rooms; see section 5.
 - ...
 - 5. *Rules for in-person teaching*
 - Teaching will generally only be carried out in person where the applicable distancing rule of 1.5 meters can be enforced. There is currently no obligation to wear masks during classes, but students may do so if they wish. In addition:*
 - *Occupation of lecture halls will be arranged according to distancing rules; seats that are not meant to be used will be removed or labeled.*
 - *Students are to wear masks on the way to their seats and again when they leave their seats.*
 - *Eating during lessons is prohibited.*
 - *Students must clean their work surfaces before the start of the lesson. Cleaning products will be provided by the relevant facility managers.*
